AMWC Conservation Programs

- Turf Conversion Program - \$0.25/sq ft up to \$500 residential (up to \$1,000 MFR, LS, Comm)
- Weather Based Irrigation Controller Program - \$100
- Pressure Reducing Valve Program - \$100
- High Efficiency Toilet Program - \$50
- High Efficiency Clothes Washer Program - \$75

AMWC Watering Restrictions

DECLARED STAGE 2 WATER SHORTAGE CONDITION

- Outdoor watering banned: 10 a.m. to 5 p.m.
- Outdoor watering days: Tues, Thurs, and Sat for properties with even-numbered addresses; Wed, Fri, and Sun for properties with odd-numbered addresses; no watering on Monday
- Newly installed landscaping: May be watered daily for the first 21 days after planting

Templeton CSD Watering Restrictions

Templeton CSD has announced mandatory water conservation restrictions as follows:

- The watering of lawns, shrubs or other landscaping that requires "spray" irrigation will be prohibited from the hours of 10 a.m. to 6 p.m.
- All wasting of water will be prohibited. Examples of water wasting include but are not limited to: washing streets, sidewalks or driveways down instead of sweeping, letting hoses run open and/or without a controlling device at the end and outside watering or irrigation practices that result in water running off the property.

Watering schedules go into effect April 1st through September 30th. All landscape is limited to no more than three assigned days per week. Even number addresses may only irrigate on Tuesdays, Thursdays, and Saturdays. Odd number addresses may only irrigate on Wednesdays, Fridays and Sundays
